## Submission of cash bid

A cash bid must be submitted to NOPTA **via email** to [cash.bidding@nopta.gov.au](mailto:cash.bidding@nopta.gov.au) during the bidding period as specified on the invitation to submit a cash bid.

Documents listed below are required to be submitted as part of the cash bid.

Checklist	Description	Attached
1	Completed and signed cash bid form (i.e. this form).	
2	Evidence of payment of the 10 per cent deposit in AUD by way of transaction receipt (also see 'Deposit' below). <b>Note:</b> <i>Deposits will be refunded to unsuccessful bidders. For the successful bidder, the balance will be required to be paid with the acceptance of the offer. Deposit forfeit rules apply if the successful bidder at or over the reserve does not accept the offer.</i>	
3	A completed creditor form to facilitate the return of the deposit should it be required.	

Email attachments must not exceed 10MB in size. Should the attachments exceed 10MB, applicants are required to split into numerous emails with a clear subject line reference to indicate that a group of emails should be considered as part of one cash bid.

The email subject line must clearly state: "*Cash Bid for Release Area [insert area], Commercial-in-Confidence*".

## Deposit

A 10 per cent deposit in AUD is required to be lodged prior to submission of the cash bid. Applicants lodging bids from overseas will need to ensure that the 10 per cent deposit is made net of all fees, such that the amount received by NOPTA is exactly 10 per cent of the bid amount stated in this form.
